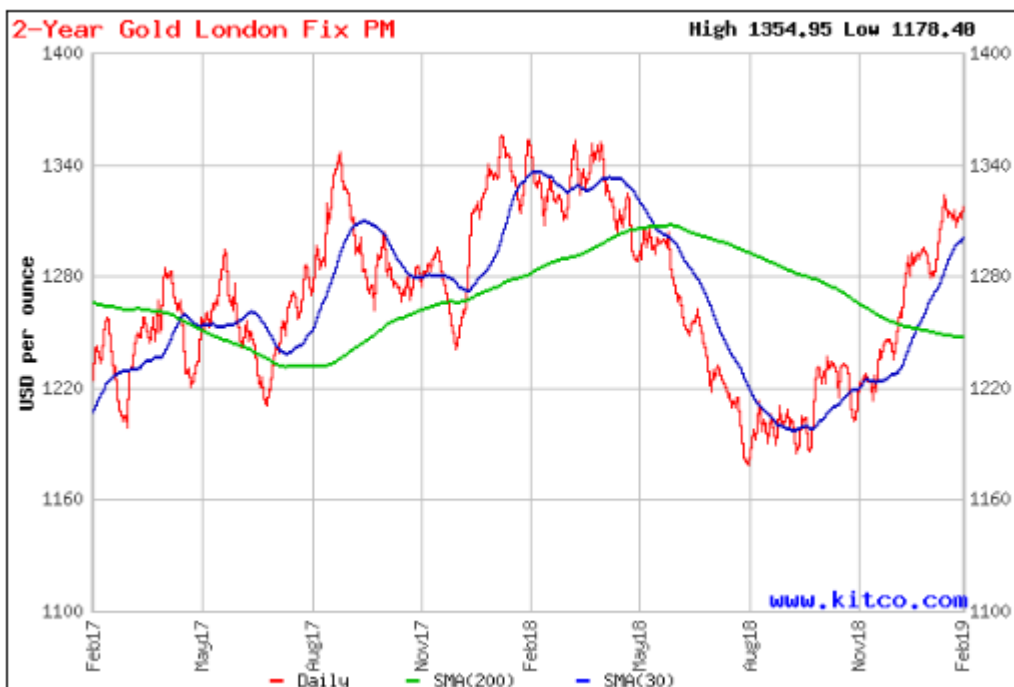
## PRECIOUS METALS COMMENTARY

Gold futures prices ended the U.S. day session with solid gains Friday, hit a two-week high and closed at a technically bullish weekly high close.

In addition to this renewed and welcomed bullish sentiment, Friday's gains in the precious metals complex occurred in tandem with a U.S. equities market that had incredible gains on the day. The Dow Jones industrial average gained over 443 points today as it closed at 25,883.25. This was a net gain of 1.74% on the day. The NASDAQ composite exhibited gains of 6/10 of a percent and closed at 7471.75.

These strong gains witnessed in U.S. equities and the precious metals were a direct result of market sentiment based upon the trade negotiations between the United States and China that were reported as making headway and getting closer to a favourable resolution. While this news only had a minor impact on the U.S. dollar it had a profoundly strong impact on U.S. equities, and to a lesser degree a strong impact on the precious metals. Source: Kitco
